# Cali Learn Summer Program Waiver & Consent Form

# 1. General Liability Waiver

I understand that participation in Cali Learn programs may involve physical activity, computer use, project-based learning, and other interactive instruction. I acknowledge that there are inherent risks associated with participation in such activities and voluntarily assume full responsibility for any risk of injury or damages that may be sustained by my child during the program.

I hereby release and hold harmless Cali Learn LLC, its owners, staff, instructors, volunteers, and affiliates from any and all liability, claims, or demands for personal injury, illness, property damage, or other losses that may arise from participation in this program, whether caused by negligence or otherwise, to the fullest extent permitted by law.

#### 2. Medical Authorization

I authorize Cali Learn staff to administer basic first aid and seek emergency medical treatment for my child if necessary. I understand that reasonable efforts will be made to contact me prior to such care, but if I cannot be reached, I authorize emergency care to be provided as deemed necessary by qualified professionals. I accept financial responsibility for any medical treatment incurred on behalf of my child.

I certify that my child is in good health and able to participate fully in the program.

#### 3. Media & Photo Release

I grant Cali Learn LLC the right to take photographs, videos, or recordings of my child during program participation and to use those materials for marketing, promotional, or educational purposes. These materials may be published on the Cali Learn website, social media, or print media.

No personal identifying information will be shared without additional consent.

## 4. Behavior & Conduct Expectations

Students are expected to behave responsibly and respectfully during the program. Inappropriate behavior, harassment, misuse of technology, or failure to follow instructions may result in disciplinary action or removal from the program without refund.

Students will use computers and online tools. I understand that my child is expected to use all technology appropriately and only for approved activities.

## 5. Cancellation & Refund Policy

An initial deposit of \$400 is included in the camp tuition and is refundable until **May 5**, **2025**. After this date, the deposit becomes non-refundable. No refunds will be issued after **June 1, 2025**, regardless of circumstances. Refund requests must be submitted in writing.

Full tuition must be paid prior to the start of the student's registered session.

## 6. Program Cancellation by Cali Learn

Cali Learn reserves the right to cancel or reschedule any program, session, or class due to low enrollment, facility issues, health concerns, or other unforeseen circumstances. In such cases, families will receive a full refund of any unused tuition, including the deposit. We will make reasonable efforts to notify families as soon as possible.

#### 7. Student Dismissal Policy

Cali Learn reserves the right to dismiss any student from the program at any time due to behavior deemed unsafe, inappropriate, disruptive, or in violation of the program's conduct expectations. No refund will be issued for dismissal resulting from behavior.

#### 8. Parent/Guardian Conduct & Dismissal Policy

Cali Learn also reserves the right to remove a student from the program due to repeated or serious violations by the student's parent or guardian. This includes habitual late pickup, failure to submit required forms, disruptive communication, or failure to follow program policies. No refund will be issued for dismissal resulting from parent or guardian conduct.

## 9. Force Majeure

Cali Learn is not liable for failure to provide services due to events beyond its reasonable control, including but not limited to natural disasters, health emergencies, severe weather, facility closures, or other force majeure events. In such cases, we will make reasonable efforts to reschedule or offer refunds when possible.

# 10. Limitation of Liability

To the maximum extent permitted by law, Cali Learn LLC shall not be liable for any indirect, incidental, special, or consequential damages arising out of participation in its programs.

## 11. Personal Property Disclaimer

Cali Learn LLC is not responsible for the loss, theft, or damage of any personal property brought to the program by students. Participants are encouraged to leave valuable items at home and to clearly label any personal belongings they do bring. Students are solely responsible for their items while attending the program.

#### 12. Indemnification

I agree to indemnify and hold harmless Cali Learn LLC, its officers, employees, and affiliates from any loss, liability, claim, or expense (including reasonable attorney's fees) arising from my child's participation in the program, including actions caused by my child.
